Cheshire East Council Proposed Changes to the Local Plan Strategy (LPS) (Consultation Draft)



Guidance Notes and Representation Form

Cheshire East Council has published its 'Local Plan Strategy – Proposed Changes Version' and accompanying documents for public consultation. This follows Inspector Stephen J Pratt issuing his Further Interim Views, in December 2015, following the second set of examination hearings on the Local Plan Strategy (LPS) between 21 and 30 October 2015. These address the additional evidence produced by the Council during the previous suspension of the examination and its implications for the submitted LPS.

Following the Further Interim Views, the Council has finalised the proposed changes to the Local Plan Strategy (LPS), with the necessary changes to the policies and accompanying text, including new and amended strategic site allocations, with all the supporting evidence. The proposed changes will now be subject to formal public consultation for a 6 week period.

Following the conclusion of the public consultation process, the Council will consider and respond to the key issues raised in the representations before submitting its final proposed changes and all of the representations to the Inspector in support of the ongoing examination of the LPS. It is anticipated that examination hearing sessions will resume in September 2016 to consider amendments to the submitted LPS and sites (including additional, amended and existing site allocations).

The Council invites representations on the Local Plan Strategy – Proposed Changes Version, as well as its accompanying documents, the Sustainability (Integrated) Appraisal and the Habitats Regulations Assessment Addendums, for six weeks from 4 March 2016 to 5pm on the 19 April 2016. Representations submitted after this time will not be accepted. In line with the Inspector's advice (19 February 2016 [RE E003]), representations should be focused on the changes that are proposed to be made to the LPS.

- The consultation will be on the Local Plan Strategy Proposed Changes Version (February 2016). This follows the full public consultation on the Local Plan Strategy Submission Version in March 2014 and the outcomes of examination processes since May 2014. The Council will accept all valid representations, though it is primarily seeking views on the proposed changes to the LPS and / or the sites. This is in line with the Inspector's advice (19 February 2016 [RE E003]), representations should be focused on the changes that are proposed to be made.
- The Local Plan Strategy Proposed Changes Version consultation document incorporates the use
 of 'tracked changes' whereby text proposed to be deleted is indicated using strikethrough text (like
 this) and proposed new text is underlined (like this). In line with the Inspector's advice dated 19
 February 2016 (exam library ref [RE E003]), representations should be focussed on the proposed
 changes.
- To assist the public to understand the changes proposed to the submitted version of the LPS, reference documents including the original Local Plan Strategy Submission Version and a 'clean' version of the Local Plan Strategy Proposed Changes version (which shows the revised LPS as proposed without the 'tracked changes') are available to view via the online consultation portal (accessed using www.cheshireeast.gov.uk/localplan).
- Representations should specify why the Plan is not legally compliant or is considered unsound and what modifications would be needed to make it legally compliant or sound.
- In terms of legal compliance, this is essentially whether the Local Plan Strategy with the Proposed Changes meets the requirements of planning legislation and associated regulations. This includes the need to provide reports relating to Sustainability Appraisal and Habitats Regulations Assessment.
- For a Plan to be judged 'sound' it has to be:
 - Justified (founded on a proportionate evidence base and the most appropriate strategy when considered against the reasonable alternatives);
 - Effective (deliverable and based on effective joint working on cross-boundary strategic priorities);
 - Consistent with national policy (predominantly set out in the National Planning Policy Framework);
 - Positively prepared (the plan should be based on a strategy which seeks to meet objectively assessed development and infrastructure requirements).
