<p>5. Matters arising Draft policy document edited to consistent style, introduction added referring to evidence documents on collected on one page on website, and circulated to all Forum members, David Johnston and Richard Wood of SMBC, and our three local councillors, Brian Bagnall, John Magahan and Mike Hurleston.</p> <p>Agreed action: EF to send it to Mary Robinson MP, and neighbouring groups in Poynton, Adlington and Marple.</p>	EF
<p>6. AGM RBe raised a question about the current role of the WCC. TB and DB explained the WNF was focussed on development of the Plan while other community matters, such as traffic issues, new road schemes, Aerodrome development and planning applications in Woodford are handled by the WCC. The membership of WNF excludes Aerodrome residents but includes people who work in Woodford. Membership of WCC includes the residents on the Aerodrome but not people who work here. This difference and division of labour will be reflected by the agendas at the respective WNF and WCC AGMs.</p>
